ECES VOCATIONAL EDUCATION AGREEMENT

Student parents/guardians can receive subsidized child care during the time they are in vocational training leading directly to a recognized trade, or profession. Child care and development services are limited to six years from the start of services due to vocational education or twenty-four units after the attainment of a Bachelor’s Degree. Approved child care hours are based on the current school schedule. A completed training verification and computer print out of class schedule must be submitted to 4Cs before child care hours can be approved. In order to continue receiving child care services for vocational education, adequate progress towards the attainment of the vocational goal must be made.

- Upon completion of a quarter, semester, or training period, as applicable, a report card, a transcript, or, if the training institution does not use formal letter grades, other records to document that the parent is making progress toward the attainment of the vocational goal must be submitted to 4Cs within 10 days.
- Adequate progress is a minimum 2.0 grade point average or in a non-graded program, pass the programs requirements in at least 50 percent of the classes or meet the institutions standards for making adequate progress.
- Online or televised classes require supporting documentation (ex: syllabus or web address)
